Declaring validity, legality and enforceability of requests for restitution and compensation expressed below,

I request the imposition of sanctions against mentioned entities and persons according to applicable law, namely, the confiscation of assets and property owned by German State, German Federal States, German citizens or their representatives, organizations and business companies, and deposited in the United Kingdom, particularly the 432 ton of gold deposited at the Bank of England, as well as property and assets stolen from Russia since 1989.

Secondly, the confiscated property and assets should be granted to me and to the Fund of the Constitutional Development (Фонд Конституционного Строительства), as justified and substantiated previously.

Thirdly, I apply for administrative assistance in order to arrest and to prosecute the Mayor of Berlin Michael Müller and members of his administration due to corruption, organized crimes, robbery,

racketeering, torturing, kidnapping and several other capital offenses, as reported or not yet reported but in any case substantiated previously.

Fourthly, due to my notarized statement of 12.12.2018 {6}, I am authorized to act on behalf of both the Fund of the Constitutional Development (Фонд Конституционного Строительства) and the community Rus' (Русь) in agreement with the rule of law specified in its Constitution {7}.
