I write to inform the Royal Courts of Justice that all property and assets stolen from Russia since 1989 must be confiscated and placed to my disposal for purposes explained in my letter of 28.09.2018 addressed to Director of the National Crime Agency and to Secretary of the Home Office. Hence, the property and assets stolen from Russia by Oleg Deripaska and frozen in the United Kingdom by the Commercial court decision of 2 October 2018 as well as the property and assets of claimant(s) in said court case are my property and shall be immediately placed to my disposal. The legal fees paid or ordered in said court case or in similar others shall be nullified and repositied for the same reasons and purposes.

Dear Home Secretary !

Due to committing serious crimes and violation of individual rights, namely money laundering, fraud, corruption, unjust enrichment, robbery, kidnapping, unlawful professional ban and numerous others, as reported previously<sup>1</sup>, I request the confiscation of the entire German wealth deposited in the United Kingdom, especially the 432 ton of gold deposited at the Bank of England, as well as property and assets stolen from Russia since 1989, in accordance with the Serious Organised Crime and Police Act of 2005, the Serious Crime Act of 2007, and the Sanctions and Anti-Money Laundering Act of 2018.

Secondly, the confiscated property and assets should be placed to my disposal in order to indemnify and to compensate me for the losses, to enable me to indemnify and to compensate the losses of other victims of organized crime and despotism, and to promote the constitutional order in Russia.

In case my request will be ignored or not responded in appropriate way by authorized and empowered persons and officials, they will be prosecuted for negligent breach of their duties, disablement, aiding and abetting of said crimes, and for obstruction of my intents.
