

О правомерности изъятия книг из обращения.

Распространяемое от имени компании Google заявление о предстоящем изъятии книг из библиотеки Google Books {1} является попыткой ввести общественность в заблуждение, и таким образом нарушает нормы права, на основании которых возможно подобное изъятие. Замалчивание факта передачи всего имущества компании Google Фонду конституционного строительства на основании постановления от 19.02.2026 {2} является антиконституционным деянием, равно как и всякие попытки действовать в обход моего исключительного права распоряжаться имуществом, переданного Фонду конституционного строительства. Далее, недопустимо обоснование подобных мероприятий какими-либо актами (документами) Европейского Союза, поскольку Европейский Союз не является правовой и правоспособной организацией. Единственным правовым обоснованием изъятия книг из библиотеки Google Books является Постановление о литературе от 5.10.2023 {3}, указание на которое должно присутствовать в объявлениях об изъятии книг из библиотек и книжных магазинов. Кроме того, как сказано в этом постановлении, изъятие книг должно сопровождаться письменным обоснованием изъятия с указанием даты и имени лица, принявшего решение об изъятии, с последующим внесением изымаемых из обращения книг в реестр. Все другие обоснования об изъятии книг из обращения, равно как и действия, не соответствующие указанному порядку изъятия, противоправны и поэтому недействительны.

On the legality of banning books.

The statement issued on behalf of Google regarding the upcoming removal of books from the Google Books {1} is an attempt to mislead the public and thus violates the legal provisions under which such a removal is permitted. Concealing the fact that all property of Google was transferred to the Foundation for Constitutional Development in accordance with the resolution of February 19, 2026 {2}, is an unconstitutional act, as are any attempts to circumvent my exclusive right to dispose of the property transferred to the Foundation for Constitutional Development. Furthermore, it is impermissible to justify such actions by any acts (documents) of the European Union, since the European Union cannot be considered a legal entity with legal capacity. The sole legal basis for the removal of books from the Google Books is the Decree on Literature dated October 5, 2023 {3}, a reference to which must be included in announcements regarding the removal of books from libraries and bookstores. Furthermore, as stated in this decree, the removal of books must be accompanied by a written justification for the removal, specifying the date and the name of the person who made the decision to remove them, followed by the entry of the books being removed from circulation into the registry. All other justifications and actions regarding the removal of books from circulation are unlawful and therefore invalid.
