

International Arrest Warrants.

Due to continuation of lawbreaking by members of a criminal organization involved in illegal surveillance, intimidation, robbery, and murder of innocent people {1 – 5}, and prohibited by the law of the Community Rus' {6}, I order the arrest of the Secretary General, President, and Vice Presidents of Interpol, namely, Jürgen Stock, Ahmed Naser Al-Raisi, Peter De Buyscher, Garba Baba Umar, Valdecy Urquiza {7 – 9}, who shall be arrested everywhere in the world on the first occasion, and detained in the penitentiary of the place of the arrest until further instructions will be given to direct them to the court responsible for trial and sentencing.

In consequence of committing tortious acts and disregard of my demands and applications, I seize assets and property of Interpol, including its headquarters in Lyon, its Global Complex for Innovation in Singapore, and its Foundation in Geneva {10 – 11}, which are placed at the disposal of the Foundation for Constitutional Development.

The refusal to hand over seized assets and property will be punished in accordance with the provisions of the Constitution of the Community Rus' and in fulfillment of the Nuremberg Principles of Law.
