Secondly, I apply for administrative assistance in order to arrest and to prosecute the Mayor of Berlin Michael Müller and members of his administration due to corruption, organized crimes, robbery, racketeering, torturing, kidnapping and several other capital offenses, as reported or not yet reported but in any case substantiated previously {15-18}.
